

#### New day/time for Cherubim-Seraphim Choir

## Proposed Amendment to the Articles of Incorporation Of Christ Episcopal Church Endowment Fund, Inc.

In the Articles of Incorporation of the Christ Church Endowment Fund, distributions to Christ Church are restricted to just interest on the "corpus." At the time the Articles were written, the "corpus" funds were held entirely in bank savings accounts and CD's. However, many years ago, a majority of the funds were reinvested in mutual funds and other higher-yield investment products. As a result, the total funds have grown dramatically. The drawback is that the "interest" limitation no longer makes sense since very little of the new growth is interest. Worse, because the existing by-laws do not address dividends, capital gains, and changes in investment value, no one now is even certain how much of the current total balance comprises the "corpus"; indeed, if today you asked each of the five board members for the current balance of the corpus, you would probably get five different answers. The proposed amendment redefines the corpus so that it can be easily determined. The amendment also changes the method of distributing funds to the church to remove the "interest" limitation. The new method is more flexible and brings it into line with how distributions are done from similar endowments at most other churches.

The proposed amendment was approved unanimously by the members of the Endowment Fund board last June and is now respectfully submitted to the membership for final approval. A vote to approve the change will be taken at the annual meeting, Wednesday, May 7, 2008. The existing Article III and proposed Article III are listed on page 5, side by side for your review.

In addition, the first sentence of paragraph 5 of Article VI is proposed to change as follows:

Old: "A nominating committee, consisting of the director of the senior most class, shall receive nominations from and by lay member of Christ Episcopal Church in good standing and select at least three candidates for nomination and presentation of their names to the Board."

Proposed: "A nominating committee, headed by a director from the senior most class, shall receive nominations from and by lay members of Christ Episcopal Church in good standing and select candidates for nomination and presentation of their names to the Board."

#### **Original Article III**

The Board of Directors (the Board) shall not be obligated to make any distributions until the corpus of the fund exceeds \$100,000.00. In determining this initial sum, the Board shall add accumulated interest to any corpus, so that the initial corpus of \$100,000.00 includes such accumulated interest. After the fund reaches \$100,000.00, then accumulated interest shall not be made a part of the corpus, except as specifically provided in these Articles.

After such time as the corpus of the funds exceeds the above amount the Board shall distribute to the Treasurer of Christ Episcopal Church on a regular basis to be determined by the Board being, no more than quarter-annually and no less than semi-annually, accumulated interest on the corpus of the fund. The board shall obtain a receipt for each distribution form the Treasurer of Christ Episcopal Church.

Furthermore, at the time of the second and each subsequent distribution, the Board shall receive a statement executed by the Treasurer of Christ Episcopal that the prior distribution was used for the purposes and in the manners set forth in Article II herein. The Board shall make no distribution until such statement is received. If no distribution is made because no statement is received, then any accumulated interest will be added to the corpus and become a part thereof. The Board may elect to terminate future distributions until the Treasurer provides such a statement, or until the Treasurer certifies that the use of future distributions are planned in accordance with Article II. The next distribution by the Board shall then be as if it were the first distribution referred to herein.

No portion of the corpus of the fund shall be distributed except for catastrophic reasons and except in accordance with Article X. What constitutes a catastrophic reason is within the discretion of the Board. However, the Board is to be mindful that it is charged to keep the corpus intact if at all possible and that a catastrophic reason for distribution should be something such as the destruction of all or a major portion of the building of Christ Episcopal Church.

#### **Proposed Article III**

The corpus of the fund is hereby defined to be \$500,000 or two-thirds of the total value of the fund as of the end of the prior calendar year, whichever amount is greater.

Unless the Vestry of Christ Episcopal Church declines a distribution, the Board shall distribute to the Treasurer of Christ Episcopal Church on a regular basis to be determined by the Board but not less than annually an amount up to but not exceeding five percent (5%) of the total value of the fund as of the end of the prior calendar year. However, such regular distributions shall never include any portion of the corpus.

Furthermore, prior to each distribution, the Board shall receive a statement executed by the Treasurer of Christ Episcopal Church certifying that the prior distribution was used for the purposes and in the manners set forth in Article II herein. The Board shall make no distribution until such statement is received. The Board may elect to terminate future distributions until the Treasurer provides such a statement or until the Treasurer certifies that the use of future distributions is planned in accordance with Article II. The next distribution by the Board shall then be as if it were the first distribution referred to herein.

No portion of the corpus of the fund shall be distributed except for catastrophic reasons and except in accordance with Article X herein. What constitutes a catastrophic reason is within the discretion of the Board. However, the Board is to be mindful that it is charged to keep the corpus intact if at all possible and that a catastrophic reason for distribution should be something such as the destruction or loss of all or a major portion of the building of Christ Episcopal Church.
